DIRECTIONS FOR USE

With herbicides: Add 1 to 4 pints per 100 gallons of spray solution during mixing. For specific rates of surfactant, always refer to the pesticide manufacturers' label. NOTE: Needed rates of CHEMPRO E-325 may vary with conditions of application.

Prior to use, read and follow all directions on this label and on the label of the pesticide being used. The pesticide manufacturer's label for specific usages and restrictions have precedence over DIRECTIONS FOR USE referred to on this label. If the applicator does not have experience using this product, a phytotoxicity (jar) test must be performed to facilitate safety and compatibility with each tank mix.

STORAGE: Store product locked up and in original container. Keep container tightly closed when not in use. Take care to prevent water from being introduced to the contents of this container. Keep away from sparks, flame, static electricity or other ignition sources.
